WHAT IS IT AND HOW CAN THE LOTTERY BENEFIT MY CLUB?

- Online lottery across Ontario (licensed by AGCO).
- Open to all Member Clubs in Ontario to participate and receive NET proceeds of the lottery to benefit and implement youth programming at their club.
- CLUB COSTS TO PARTICIPATE \$ 0.00.



- Clubs sign contract to participate. (Special statement about unlicensed lotteries at club)
- CurlON will install a tablet in club with access to internet for use as a public display and access to purchase tickets.
- Any resident of Ontario over the age of 18 is eligible to purchase a ticket.



- Financial information:
- 50% to the winner
- 1% to AGCO (license fee)
- 2.2% to Credit card processing fees
- \$ 1.00 per transaction to Ascend (online program)
- 33.5% to Participating Curling Clubs
- 3.1% to CurlON for program management (estimated costs)



- At next release ... ticket purchasers will be able to tag which club they are supporting with their purchase. Funds will only be distributing to participating clubs.
- At year-end (April 30) clubs will be asked to invoice CurlON for their share of lottery proceeds and a check will be issued along with the fully audited financial report of the lottery.

Ascend Fees (\$1.00 / transaction)	105,560
Ascend Equipment Fee	1,040
Ascend – One Time Setup fee	1,000
BALANCE FOR DISTRIBUTION	\$ 386,608
Participating Clubs (33.5%)	353,760
CurlON Costs **	32,848

** CurlON costs will be fully reviewed and presented to the participating clubs after the audit report.

This example was based on 30 clubs participating which returns an average of \$ 11,792 per club for 5 months effort.
